3. Vendors are responsible to supply your own tents, tables, chairs and other merchandising supplies for your own booth. Vendors are required to check-in and claim your space between **7:30 and 8:00 a.m.** or your space may be forfeited. Booth space is to be set-up and open for business by **9:00 a.m.** and is to remain open until the event closes at **3 p.m.**
4. Vendors display all merchandise at your own risk. Val Vista Lakes Community Association and Audrey Thacker are not responsible for damage, theft, or loss of merchandise or booth facilities.
5. Vendors are responsible for the cleanliness of your own booth space and the surrounding area throughout and at the close of the art fair.
6. Vendors agree to allow the use of videos and photographs taken during the art fair for promotional purposes.
7. Vendors agree to obey all the pertinent codes, laws, ordinances and regulations, including but not limited to ; fire, safety and parking. Canopy tents must be flame retardant.

Val Vista Lakes Community Association, as well as, Audrey Thacker are not liable for refunds, or any other liabilities for the vendors failure to obey the rules and regulations or due to the unstable condition of the area in which the art fair is held, caused by but not limited to; weather, fire or other calamity.
